Vehicles must be purchased for Business use and be registered in your Business Name.

Recommended Business Fleet Plan prices are listed for the nominated vehicle and factory fitted options, however the actual price paid will be determined by agreement between you and the Dealer. The price of Dealer fitted options and accessories and the value of any trade-in vehicle are subject to negotiation between you and the Dealer.

A Vehicle Delivery Fee is payable to the delivering Dealer to cover the cost of vehicle freight, pre-delivery, detailing and administrative activities. The actual Dealer Delivery Fee you are charged will be determined by agreement between you and the Dealer.

Any misrepresentation of a Business' eligibility to purchase products under the Business Fleet Plan may result in legal action being taken to recover the difference between price paid by the registered Business and the Recommended Retail Price of the Vehicle.
